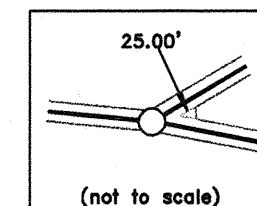

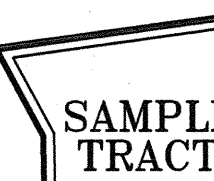
Topographical information shown was digitized from U.S.G.S. 7.5 minute quadrangle maps.
Roads shown hereon shall be sixty (60) feet in width, thirty (30) feet either side of centerline.

All cul-de-sacs shown hereon shall have a diameter of one hundred twenty (120) feet - a radius of sixty (60) feet.

All "Y" shaped road intersections, there shall be an additional twenty-five (25) foot right-of-way "cut-back" from the acute angle of the intersection as shown below.

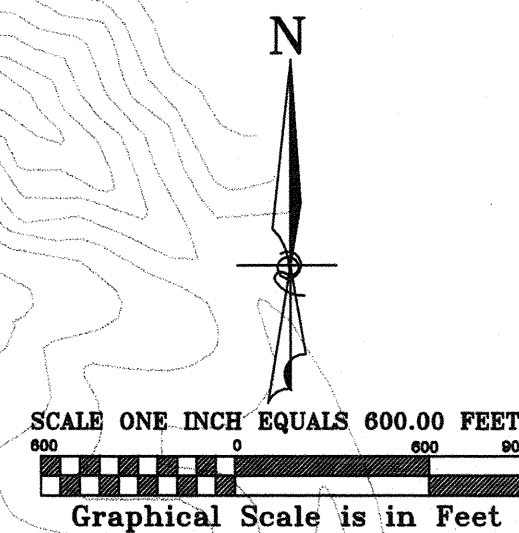
